



Style Crest® Valor Vinyl Skirting Limited Warranty

WHAT THIS WARRANTY COVERS – PANEL HOLES WARRANTY

Style Crest®, Inc. warrants that, if a Valor Vinyl Skirting panel incurs accidental damage that results in a hole in the skirting panel, Style Crest, Inc. will, at the sole option of Style Crest, Inc., either replace the affected panel(s), or refund the original purchase price paid for the affected panel(s) in accordance with the applicable terms and conditions contained in this document. This "Panel Holes Warranty" is extended only to the original purchaser of the Valor Vinyl Skirting panel(s). The duration of this "Panel Holes Warranty" is one (1) year from the date of installation of the Valor Vinyl Skirting panel(s), however, the duration of the "Panel Holes Warranty" will be extended to five (5) years if the original purchaser of the Valor Vinyl Skirting panel(s) registers the warranty online at www.stylecrestinc.com within 30 days after the date the Valor Vinyl Skirting panels are installed. This "Panel Holes Warranty" includes and is subject to the other applicable terms and conditions in this document.

WHAT ELSE THIS WARRANTY COVERS – MANUFACTURING DEFECTS WARRANTY

Style Crest®, Inc. warrants its Valor Vinyl Skirting panels to be free from manufacturing defects. If any of the panels has a manufacturing defect, Style Crest, Inc. will, at the sole option of Style Crest, Inc., either replace the affected panel(s), or refund the original purchase price paid for the affected panel(s) in accordance with the applicable terms and conditions contained in this document. The duration of this "Manufacturing Defects Warranty" is five (5) years from the date of installation of the Valor Vinyl Skirting panel(s), however, the duration of the "Manufacturing Defects Warranty" will be extended to ten (10) years if the original purchaser of the Valor Vinyl Skirting panel(s) registers the warranty online at stylecrestinc.com within 30 days after the date the Valor Vinyl Skirting panels are installed. This "Manufacturing Defects Warranty" includes and is subject to the other applicable terms and conditions in this document.

WHAT THIS WARRANTY DOES NOT COVER

This limited warranty does not cover labor or related charges for removing any damaged or defective panels or installing any replacement panels. In addition, neither the "Panel Holes Warranty" nor the "Manufacturing Defects Warranty" apply to holes or other damage to Valor Vinyl Skirting panels that are caused by any of the following:

- *Holes or other physical alterations that are intentionally made or which reasonably should have been expected to result from intentional acts or conduct*
- *Failure to install the Valor Vinyl Skirting panels in accordance with all the applicable instructions and guidelines provided by Style Crest, Inc.*
- *Hurricane, flood, fire, tornado, earthquake, wind, lightning, hail, water, snow, ice, freezing, frost, or any other act of nature or uncontrollable force*
- *Failure to maintain or care for the Valor Vinyl Skirting panels in accordance with all the applicable instructions and guidelines provided by Style Crest, Inc.*
- *Building or foundation settling*
- *Air pollution*
- *Normal wear and tear or normal weathering of the surface of the Valor Vinyl Skirting panels*
- *Abuse, neglect, or misuse of the Valor Vinyl Skirting panels*

Under this limited warranty, the obligation of Style Crest, Inc. is limited to replacement of the product or, at the sole option of Style Crest, Inc., refund of the original purchase price paid for the product. Style Crest, Inc. will have no other obligation and shall not be liable for any incidental or consequential damages, direct or indirect, including but not limited to damage to property, personal injury, bodily injury, lost profits, or any other damages arising out of the sale or use of the product, regardless of the legal theory claimed.

This limited warranty is the exclusive warranty and is expressly in lieu of all other warranties, expressed, implied, and statutory. Style Crest, Inc. expressly disclaims all other warranties including, without limitation, implied warranties of merchantability and fitness for a particular purpose, even if Style Crest, Inc. suggests the product's use for a particular purpose.

HOW TO MAKE A WARRANTY CLAIM

To make a claim under this limited warranty, send written notice and a description of the claim and issues to: Style Crest, Inc., 2450 Enterprise Street, Fremont, Ohio 43420, Attn: Warranty Administrator. Notice of a claim must be provided within ten (10) days of the discovery of the condition, giving rise to the claim. Style Crest, Inc., must be provided a reasonable opportunity to investigate any claim. The following documents and information must be provided for any claim: (1) copy of the original invoice showing the date of installation of the Valor Vinyl Skirting panel(s) involved in the claim; and (2) color photographs that show the damage and/or defects relating to the Valor Vinyl Skirting panel(s) involved in the claim.
